Minutes of the NSMBA Committee Meeting held at Bridgman Bowls Club on Tuesday 19th November 2024

BN welcomed and thanked everyone for attending.

1. Minutes of Meeting 10th September 2024

The previous Minutes were distributed and read.

Proposed as a true record, agreed as correct.

2. Matters arising:

All action points have been addressed and completed

3. Chairman's Report:

I would like to thank the Committee for all the hard work they continue to put in.

I went over to Adam's and we had a bit of a training session about updating the Website with the League Results.

The Website has been updated to accommodate the new leagues and are being populated as games are played.

All the Trophies were collected in, bar one, the Mixed Fours Shield.

I used a redundant shield to replace the missing one. All the trophies have been ordered and should be ready to be picked up on Thursday 21st November 2024.

I intend to get to Bridgman Bowls Club early on Saturday 23rd November to display them and add an NSMBA insert where possible.

The cost of trophies has more than doubled but that is because we have provided trophies for the League winners and Runners-Up instead of certificates as we did last year as requested by NSMBA members.

4. Acting membership Secretary's Report:

We now have a total of 258 members registered with the NSMBA, 14 Fully Registered Clubs and 4 Affiliated Clubs.

Of these members, 148 have also registered with the ESMBA

5. Secretary's Report:

Everything up to date, Minutes of meetings typed and distributed promptly.

6. Treasurer's Report:

- 6a. Bank balance remains healthy.
- 6b. Members registration fee paid to ESMBA.
- 6c. Treasurer reported that Lloyds Bank is changing banking rules for Clubs and proposing to charge for any transactions. BH to investigate banking with other banks.

- 6d. It is recommended and requested that payments to NSMBA should be by Bank Transfer Payments to NSMBA. Cheques to be avoided wherever possible.
- 6e. A Card Payment machine to be considered to receive payments.

7. Captain and Acting League Co-ordinator's Report:

- 7a. Due to insufficient number of players available the County away game against Norfolk had to be cancelled. This match will be re-arranged in the New Year
- 7b. DE reported that the County match against Suffolk was hard fought in good spirits.

 Northants played extremely well against Cambridge and both home away matches were won by Northants.
- 7c. League fixtures are now under way and results are being posted on the Website.
- 7d. It was noted that some clubs are finding it difficult to complete their games within the two hour/
 Club estimated session time limit. This may mean some clubs incurring an extra cost
 for the extra hire time of the venue. This situation has historically been the case and is no
 different now. It is unfair to expect visiting teams to play without having a roll-up.
 Teams Captains can however reach an amicable agreement not to roll-up.
- 7e. AH reported that the 5 a-side results are managed via an XL Spreadsheet and are also posted on the Website.
- 7f. All participating clubs are reminded that the 8 A-Side results should be forwarded to Dave Ekins and the 5 A-Side results forwarded to Adam Hawkings.
- 7g. AH reported that the Over 60s (are not part of the National Competitions). 9 Teams of four entered, match played at Harpole was successful and is considering introducing and including Part Two for next season. It was noted that a neutral venue is being considered such as Bridgman BC where games can be played on a Sunday.

8. County Manager's Report:

8a. Three Matches.(Over 55s, Triples and Mixed Fours) played; 3 more (Singles, Pairs and Triples outstanding). Last date for entry 30th November 2024

9. Trophies

All trophies returned and now being inscribed. BN to collect from Trophy shop ready for Presentation day.
